Re: Recycling and Trash Pick up

With summer winding down and fall fast approaching we thought this would be a good time to remind everyone of the upcoming change to the recycling schedule. Beginning the first week of September recycling pickup will return to its every other Monday schedule. The first Monday in September is Labor Day so both trash and recycling will be picked up on Wednesday September 3rd.

Please see reverse side for updated sorting instructions for recycling. Please note recycling **will not** be picked up if it is not sorted correctly.

A quick overview is as follows:

- Trash and recycling should be out by the road by 8:00 AM.
- Trash and recycling must be close to the road and visible.
- Pickup is one way; the trucks will not stop on the way back.
- Please do not overstuff your Purple bags (30 to 35 pounds at the most).
- Aluminum and tin must be separated.
- Paper, corrugated cardboard, and boxboard must be separated.
- No cardboard over 34 inches.
- No caps on plastic bottles or containers.

Items that are not recyclable:

- Styrofoam
- Pizza boxes, Paper plates, Paper towels, Tissues
- Black plastic, Plastic plant pots

Batteries can be brought to the Town Office for recycling; they will not be picked up curbside.

Contingency Plan: In case of mechanical difficulty or if the truck is full before the route is finished Hodgdon's will post to Maidstoners For Life and return on Wednesday. If it is a holiday weekend Wednesday pickup already, they will post the return date.

HOUSEHOLD TRASH BAGS: Tax-paying residents receive 52 trash bag/year free. Tax-paying nonresidents receive 26 trash bags/year. Pick up or purchase additional trash bags at town office.

SORTHEMS

MIXED PAPER

Newspapers, catalogs, telephone books, glossy inserts, paperback books, colored & white paper, wrapping paper and junk mail. Any color or type of paper.

NO brown Kraft bags, boxboard, coffee cups, ice cream cartons, or metallic wrapping paper.

TIN CANS

Labels are OK. Flattening not required. Separate from aluminum cans. Tin is magnetic.

MUST BE RINSED

GLASS BOTTLES & JARS

*Rinse, Remove Lids (recycle with tin) *
NO porcelain, Pyrex, windows, crystal,
light bulbs, lids, metal or wood.

CORRUGATED CARDBOARD, BOXBOARD, & BROWN KRAFT BAGS

All Cardboard and Boxboard food packaging. Remove excess tape. Staples are OK.

NO wax-coated cardboard, cardboard soiled with food, coffee cups, ice cream cartons, or Styrofoam.
BOXES MUST BE FLATTENED

ALUMINUM CANS, FOIL AND FOOD TRAYS

Labels OK. Flattening not required.

NO snack bags, candy wrappers, coffee bags.

MUST BE RINSED

BATTERIES

All types including primary and rechargeable batteries.

Please bag similar types together and bag damaged

batteries separately.

PLASTIC CONTAINERS #1 - #4 & #5 Food Containers

REMOVE CAPS / MAX. SIZE- 2 Gallons / NO BLACK PLASTIC / *MUST BE RINSED*

Includes food containers, health/beauty product, and cleaner containers. #5 included if it's a food container.

NO black plastic, screw-top caps, motor oil bottles, pesticide bottles, vinyl siding, toys, CD cases,

<u>HOUSEHOLD HAZARDOUS WASTE</u> — May through September in Lyndonville **BY APPOINTMENT ONLY**, and special events throughout the District. June — September. Call for details.

TOWN OF MAIDSTONE WASTE AND RECYCLABLE DISPOSAL INFORMATION

Vermont Legislature unanimously passed the Universal Recycling Law (Act 148) in 2012, which bans the three categories of materials from the trash in Vermont: Recyclables, Yard Debris and Food Scraps. In an effort to assist you, the Town of Maidstone, provides a list of Recyclable items.

Bags are available annually in July and can be picked up at Town Hall. You may pick up your free 52 bags for full time residents and 26 bags for seasonal residents, allowing 1 bag per week per year. You may put out more than one purple bag per week.

- 1. If you use your bags before July, you may purchase additional bags. <u>EACH ROLL OF</u> 26 BAGS will cost \$78.00, or purchase the bags at \$3.00 per bag.
- 2. The bags hold up to 30 to 35 pounds each. The bags are purple and are imprinted with "Town of Maidstone" in black print. Unofficial bags will not be picked up. If you use a trash bin, you may place the bag in the bin. (Due to a Resin shortage, in 2021, the Selectboard had to approve use of a purple bag "Official Use" in addition to the "Town of Maidstone" temporarily.)
- 3. Lists of items that need to be recycled are included with this information, as well as lists of acceptable bulky item disposal materials that shall be collected on July 19th, at 1342 Route 102, between 8 a.m. and noon at Bradley and Cheryl McVetty's residence. See below for other acceptable items.
- 4. The 2024 Waste Schedule is attached.
- 5. Continue to place recycling in separate recycling bins according to recycling guidelines.
- 6. The more you recycle, the fewer purple bags you will need. Why not agree to combine with a neighbor who only uses a small portion of their bag?

BULKY WASTE, METALS, & HOUSEHOLD WASTE COLLECTION DAY – JULY 19, 2025 8 a.m. to noon, 1342 VT Rte. 102 (Bradley McVetty's)

Acceptable Bulky items include but are not limited to: couches, chairs, mattresses, box springs, painted or stained wood, pressure treated wood, plywood, fiberglass insulation, roofing shingles, toilets, sheetrock, carpets, non-metal sinks & bathtubs, windows, propane cylinders, refrigerators, freezers, air conditioners & non-recycle plastics.

Acceptable Metal items include but are not limited to: metal sinks & bathtubs, stoves, grills, dishwashers, microwave ovens, water heaters, furnaces, conventional ovens, white goods metal car parts, pots & pans, steel copper brass aluminum and tin. Tires accepted for a fee depending on size and if on rim.

HHW Collections are free and open to residents of all DISTRICT TOWNS

What are *Household Hazardous Products*? They are consumer products that contain ingredients that **may be:**

Toxic-poisonous if eaten, breathed, or absorbed through the skin

Corrosive- can burn or destroy living tissue if spilled on skin

Reactive- creates fumes, heat, or explosion hazards if mixed with certain materials such as water

Explosive- can explode with exposure to heat or pressure

Flammable/Ignitable- can easily be set on fire

To determine if a product in your home is hazardous, check the label for the following words: Danger indicates that the substance is extremely flammable, corrosive, or toxic.

Poison means that the substance is highly toxic.

<u>Caution/Warning</u> is put on all other hazardous substances that are a somewhat lesser hazard, but are still dangerous if the directions are not followed closely.

Conditionally Exempt Generator businesses can also use the Lyndonville collections for the actual cost of the disposal of their materials. Please call ahead for pricing and an appointment.
