Posting of Vacancies on Zoning Board and Planning Commission:

- Discuss and act upon appointment of Bruce Barker, currently an Alternate Member of the Planning Commission and the Zoning Board of Adjustment, to full member position on both
- Discuss and decide the number of vacancies to be posted, both full members and alternate, on the Zoning Board and on the Planning Commission*
 - *Maidstone Zoning Bylaws §503 and §504 state that both the Planning Commission and the Zoning Board "shall consist of not fewer than three (3) nor more than nine(9) members appointed by the Selectboard for specified terms in accordance with 24 VSA §4460(b) and (c). The Selectboard also may appoint alternates for specified terms to serve on the Zoning Board of Adjustment in situations when one or more members of the Board are disqualified or are otherwise unable to serve." According to 24 V.S.A. § 4460, "the municipal legislative body may appoint alternates to a planning commission, a board of adjustment, or a development review board for a term to be determined by the legislative body."
- Discuss and decide when to post the vacancies and for how long
- Decide on deadline for receipt of letters of interest by Town Clerk at Town Hall; letters will be forwarded for review to the Planning Commission, which will make appointment recommendations to the Selectboard within a time period specified by the Selectboard
